TAKE NOTICE that a petition (the **Petition**) has been presented to the High Court of Ireland (the **Court**) seeking approval for a scheme for the transfer of the business of Aetna Health Insurance Company of Europe DAC (**AHICE**), having its registered office at Alexandra House, 3 Ballsbridge Park, D04 C7H2, Ballsbridge, Dublin, Ireland, to AWP Health & Life SA, which is part of the Allianz group (**AWP**), having its Irish branch office at 15 Joyce Way, Park West Business Park, Nangor Road Dublin 12, Dublin, Ireland and its registered office in France at 7 Rue Dora Maar, 93400 Saint-Ouen Sur Seine, France (the **Scheme**). The business which is proposed to transfer under the Scheme consists of the entire business of AHICE including a portfolio of non-life insurance policies in Classes 1 (Accident), Class 2 (Sickness), and Class 18 (Assistance) as such classes are currently set out and described in Schedule 1 to the 2015 Regulations, with liabilities or contingent liabilities remaining at the date of the Scheme (the **Transferring Policies**).

AND FURTHER TAKE NOTICE that a copy of this Notice, the Petition (incorporating the said Scheme) and the report of an Independent Actuary on the Scheme will be available for inspection by the policyholders and shareholders of AHICE at its registered office in Ireland, and the policyholders and shareholders of AWP at its branch office in Ireland, and AWP's registered office in France at 7 Rue Dora Maar, 93400 Saint-Ouen Sur Seine, France at between the hours of 9.30 a.m. and 5.00 p.m. on each working day from the date hereof until 31 October 2023 (both dates inclusive). Any person who wishes to be heard at the hearing of the Petition, should send written notice of their intention to so appear, indicating whether they wish to support or object to the proposed transfer to A&L Goodbody LLP, solicitors for AHICE at 3 Dublin Landings, North Wall Quay, Dublin 1, D01 C4E0 Ireland (Ref: LMM/LXS) to arrive no later than 5.00pm on 31 October 2023. Any person who wishes to make submissions at the Court hearing or rely on evidence should file an affidavit setting out those submissions or the evidence on which they propose to rely with the Court and serve a copy of that affidavit on A&L Goodbody LLP at the aforementioned address to arrive no later than 5.00pm on 31 October 2023.
