published in the State, namely the Irish Times and the Irish Independent, and once in
The Times (International Edition) all on or about 11 July 2023, and that, for the
purposes of this direction, the said notice to be published shall be substantially in the

form of the draft notice set out at Exhibit **BOR10** to the AHICE Affidavit (the "Notice")

3. the Petitioners shall cause the publication of such notices as are required in each EEA Member State in which the risks are situated in accordance with the requirements of the respective laws of each such EEA Member State 4. the Petition (incorporating the Scheme as a Schedule) the Notice and the independent actuarial report exhibited at Exhibit **BOR9** to the AHICE Affidavit (and a summary thereof) and a summary of the Scheme (together the "Transfer **Documentation**") shall each be made available for inspection by the policyholders and shareholders of AHICE and AWP in English at the registered office of AHICE at Alexandra House, 3 Ballsbridge Park, Ballsbridge, Dublin 4, D04 C7H2, Ireland, at the registered office of AWP's Irish branch at 15 Joyce Way, Park West Business Park, Nangor Road, Dublin 12, Ireland and at the registered office of AWP in France at 7 Rue Dora Maar, 93400 Saint-Ouen Sur Seine, France in each case for a period of at least fifteen working days after publication of the Notice in Iris Oifigiúil 5. copies of the Transfer Documentation be made available online at www.aetnainternational.com/en/about-us/insurance business transfer/irelandinsurance-business-transfer.html and a link to this website will be placed on www.allianzcare.com until the hearing of the Petition 6. any person who wishes to be heard at the hearing of the Petition should send a

notice of their intention to so appear in writing to A&L Goodbody LLP at 3 Dublin Landings, North Wall Quay, Dublin 1, D01 C4E0, Ireland (Ref: LM/LXS) to arrive no later than 5.00 o'clock in the afternoon on the 31st day of October 2023 indicating whether they support or object to the proposed transfer and that any person who wishes to make submissions at the Court hearing or rely on evidence should file an Affidavit setting out those submissions or the evidence on which they propose to
